ORDINANCE No. 3-05

**An Ordinance to Amend Ordinance No. 6-99,  
an Ordinance to Prohibit Smoking in Certain  
Restricted Areas of Buildings and Property Under the  
Ownership Or Control of the City of Clanton, a Municipal  
Corporation; to Designate Certain Areas Where Smoking is  
Permitted; to Provide a Penalty to be Imposed on any  
Person in Violation of this Ordinance.**

BE IT ORDAINED by the City Council of the City of Clanton, Alabama, a municipal corporation, in a regular meeting assembled, that Ordinance No. 6-99 and any and all amendments thereto, be and the same is hereby, amended as follows:

Section I. Definitions:

Is amended by the addition thereto of the following:

Section I. A. "Smoking" or "Smoke" or "Smokeless Tobacco" shall include the carrying, holding or possession of lighted smoking materials in any form, including, but not limited to, the possession of lighted cigarettes, cigars, pipes and smokeless tobacco products.

Section I. B. "Public" or "Public Place" shall include any enclosed or unenclosed area, including, but not limited to, the City Hall, City Shops, and City Parks used in connection with and under the control of The City of Clanton wherein the City employees are assigned or work.

Section II. Offenses:

A. Hereafter and upon the adoption of this ordinance, smoking is prohibited in the City Hall building, city shops, or enclosures used in connection with and under the control of the City of Clanton, except as hereinafter provided.

B. Hereafter and upon the adoption of this ordinance, smoking is prohibited in the City Parks, except as hereinafter provided:

1. Clanton City Park. Smoking and smokeless tobacco will be allowed outside the wood-fenced areas at Clanton City Park. For areas at Clanton City Park not enclosed by a wood fence, namely, the football field and baseball/softball fields #4 and #5, smoking and smokeless tobacco will be allowed outside 100 feet from the bleachers.

Smoking and smokeless tobacco will be allowed outside the pool facilities.

There will be no smoking or smokeless tobacco within playground areas.

2. Goosepond Park. No smoking or smokeless tobacco is allowed beyond the bridge entrance.

3. E. M. Henry Park. No smoking or smokeless tobacco is allowed within the fenced areas.

Section III. Exceptions:

The provisions of this ordinance do not apply to areas designated as "Smoking Areas".

Be it further ordained that all further terms and conditions of said ordinance, as last amended, are hereby confirmed and adopted except as herein provided.
